

- Awaiting ACLR surgery


His team advanced to Sweet 16 Basketball tournament without him.


Played Puck in A Midsummer Night's Dream

He Quit the Play








Emotional Effect of ACL injuries in young patients: Loss of Identity...

 - Not Allowed to Live as Himself




I consoled the family.

There remains a paucity of objective criteria and consensus guidelines to facilitate the decision of RTP after ACLR

- More Emphasis on Psychological state Kinesiophobia or Fear of Reinjury
- Need reliable consensus guidelines with objective and subjective criteria prior to RTP

- **Include Kinesiophobia Self Efficacy Scales in pre op and functional assessment before return to play**
- **Younger <20 years are more likely to sustain ACL retear**
- **Athletes at risk for reinjury can be identified by measures like ACL-RSI**


